The alternatives for foreigners wishing to apply for permission on services providing to associated enterprises are as follows;

- The filing of application for FOREIGN
 BUSINESS LICENSE under Section 17
- The filing of application for FOREIGN BUSINESS CERTIFICATE under Section 12, for business that has been promoted under the Investment Promotion Law

FOREIGN BUSINESS LICENSE (FBL)

The following evidence and documents are required:

- 1. A declaration of details of the type of business
- 2. Application forms "Tor.2"
- 3. An applicant's letter certify that the applicant, director, manager or agent appointed fulfills eligibility criteria and is not under prohibition under Section 16 of the Foreign Business Act, B.E. 2542 (1999)
- 4. A certificate and a declaration of the proportion of shareholdings between Thai persons and foreigners, the number of shares and the class or kind of shares held by foreigners: form "Bor.Or.Jor.5"
- 5. A map indicating the approximate location of the place of business operation in Thailand
- 6. A power of attorney form, in case another person has been authorized to act on the applicant's behalf
- 7. A copy of the house registration, a certificate of residence in the Kingdom or evidence of permission to enter the Kingdom for temporary stay under the law on immigration of an authorized representative and a grantor of authorization
- 8. Documents or evidence of business conducted under specific laws (If any)

ONLINE

FOREIGN BUSINESS CERTIFICATE (FBC)

The following evidence and documents are required:

- 1. A power of attorney in the case where another person has been authorized to act on the applicant's behalf
- 2. A copy of the passport, identification card of a grantor of authorization
- 3. A copy of the identification card of an authorized representative
